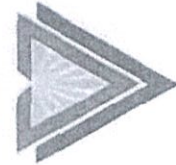

**BAC Resolution No. 2022-07-055**

**RECOMMENDING THE APPROVAL OF THE UPDATED ANNUAL  
PROCUREMENT PLAN OF THE ANTI-RED TAPE AUTHORITY FOR THE 1<sup>ST</sup>  
SEMESTER OF FISCAL YEAR 2022**

**WHEREAS**, pursuant to Section 7.2 of the 2016 revised Implementing Rules and Regulations of Republic Act (RA) 9184, no procurement shall be undertaken unless it is in accordance with the approved Annual Procurement Plan (APP), including approved changes, and must be consistent with the duly approved yearly budget of the Procuring Entity (PE);

**WHEREAS**, Section 7.4 of the same Rule, provides:

*“Changes to the individual Project Procurement Management Plans (PPMPs) and the consolidated APP may be undertaken every six (6) months or as often as may be required by the Head of the Procuring Entity (HoPE). The respective end-user or implementing units of the PE shall be responsible for the changes to the PPMPs, while the BAC Secretariat shall be responsible for the consolidation of these PPMPs into an APP, which shall be subject to the approval of the HOPE.*

*Changes in the APP, if any, for the budget year shall be submitted to the Government Procurement Policy Board in July of the current year, and in January of the following budget year.”*

**WHEREAS**, end-users submitted supplemental PPMPs to reflect changes in their respective PPMPs and were consolidated by the BAC Secretariat into APP;

**WHEREAS**, Section 7.4 of the same Rule requires the approval of the HoPE for the updated APP;

**NOW, THEREFORE**, We, the members of the ARTA – BAC, hereby RESOLVE as it is hereby RESOLVED to recommend to the Head of the Procuring Entity, **OFFICER-IN-CHARGE ERNESTO V. PEREZ**, the approval of the updated Annual Procurement Plan for 1<sup>st</sup> Semester of Fiscal Year 2022.
